#### The main responsibilities include:

- Administering, implementing and maintaining security systems, supporting the central enterprise risk management of application and systems, providing solutions and remediation to those;
- Designing and implementing data confidentiality, data availability, and data integrity processes & procedures;
- Insuring application's vulnerabilities are identified and managing and documenting the remediation tasks accordingly;
- Administering and managing of security platforms and related applications;
- Providing technical support to other information systems development staff and to endusers on issues related to systems security, technical controls audits and risk management;
- Developing technical documentation and guidance on proper and secure installation, creation, handling and maintenance of data, including imports, exports, validation, and data protection procedures;
- Researching, evaluating, and recommending new security technologies; establishing and implementing industry best practices and standards regarding server's security, data confidentiality and availability, and efficient data management processes;
- Assisting in designing and building data & system security breaches/issues monitoring, detection and response platforms;
- Implementing security strategies to maintain security of user-level access rights to systems and databases;
- Maintaining security by testing and reviewing applications, database systems & platforms patches and upgrading as necessary.

#### To qualify for this position, you will need:

#### Conditions of service

Monthly basic salary **US\$ 1592.60 plus special occupation allowance of 12.32% of the basic salary.** Other benefits include monthly Provident Fund contribution (15% of basic salary paid by the Agency), compulsory medical insurance, 30 days of annual leave, and dependency allowance (if applicable).

rescinded.
